SUBJECT: MEMORANDUM OF UNDERSTANDING BETWEEN CHIPPEWA COUNTY,  
EAGLE WASTE AND RECYCLING, PROVYRO WASTE SERVICES, EXPRESS  
DISPOSAL AND THE CITY OF CHIPPEWA FALLS

For your signature, find attached a copy of Memorandum of Understanding (MOU) between Chippewa County, Eagle Waste and Recycling, ProVyro Waste Services, Express Disposal, and the City of Chippewa Falls.

The memorandum of understanding is an agreement for collaboration on the collection, transfer, processing, and marketing of recyclable materials from Chippewa Falls and any other municipalities that enter into a processing contact with Eagle Waste and Recycling, Inc.

This is a five (5) year MOU extending from June 1, 2016, to December 31, 2020.

If there are no outstanding concerns, the agreement should be signed upon your review.



**Collaboration on the Collection, Transfer, Processing, and Marketing of Recyclable Materials  
from Chippewa Falls, WI and any Other Municipalities that enter into a Processing Contract  
with Eagle Waste and Recycling, Inc.**

1. This is a Memorandum of Understanding between the County of Chippewa, Wisconsin, hereafter referred to as the "County" and Eagle Waste and Recycling Inc. hereafter referred to as "Contractor", the City of Chippewa Falls, ProVyro Waste Services, LLC and Express Disposal. The MOU is not intended to imply that ProVyro Waste Services, LLC or Express Disposal is a contractor with the County.
2. That collaboration will consist of the following:
  - a) ProVyro Waste Services, LLC has a contract to collect single stream recyclables from residential properties in the City of Chippewa Falls. ProVyro Waste Services delivers these recyclables to the Express Disposal transfer station located at N14985 Tieman Ave, Thorp, WI 54771 under an agreement between these two parties.
  - b) Express Disposal delivers single stream recyclables collected from residential properties in the City of Chippewa Falls to the Eagle Waste and Recycling facility located at 701 Recycling Way, Eagle River, WI 54521 under an agreement between Chippewa County and Eagle Waste and Recycling.
3. Roles
  - a. The County will be the project manager.
  - b. Eagle Waste and Recycling Inc., ProVyro Waste Services, LLC and Express Disposal will collect, transfer or process single stream recyclables from municipalities that enter into a contract with Eagle Waste and Recycling Inc. through the County master contract.
  - c. Other collaborators will be involved only if all parties agree.

- d. ProVyro Waste Services, LLC will provide monthly tonnage reporting to Chippewa County and Eagle Waste and Recycling.
4. The financial arrangements will be as follows:
- a. There will be no County funding for Items 2a) and 2b) above. Each Party will be responsible for our own time and expenses under agreements between those parties.
5. Implementation of the collection, transfer and processing. All parties hope and expect that this collaboration will extend beyond the collection and processing of material from Chippewa Falls, WI, and will include its eventual promotion, subscription, and other program developments. We will discuss and resolve that collaboration when the contractual terms of the collection contract or the processing contract is approaching expiration.
6. The County hereby indemnifies and holds harmless ProVyro Waste Services, LLC or Express Disposal for any claims, demands, actions and causes of actions, debts, demands, liabilities and losses of any kind or nature whatsoever arising from or relating to the collection and transfer of recyclable materials, and all other uses or subsequent activities on land to be leased by ProVyro Waste Services, LLC or Express Disposal and its business relationships.
7. Term. This agreement will take effect on June 1, 2016 and will expire on December 31, 2020 unless all parties agree to extend it. It can be cancelled by any party, without penalty, by written notice.
