Items of business to be discussed or acted upon at this meeting are shown on the agenda below:







New sign location is approx 250' from Land Zoned Residential





Dear Members of the City of Chippewa Falls, Committee #3,

My name is Cory Vajgrt. My wife, Katelyn, and I own the building located on the corner of Bay and Spring Street, downtown Chippewa Falls. We operate Current Catering, formally Jane's Catering, out of this building. Our business address is 36 W Spring St. The building does not have alley access or a back door due to the position and layout of the neighboring buildings. There are buildings to the North and East. City sidewalks border our South and West walls. (Please see attached photo)

We are experiencing difficulties setting up garbage and recycling services because we do not have storage space for garbage/recycling cans, or alley access.

There is a permanent, metal, city owned, garbage receptacle located on the Bay St. sidewalk, about 6 feet outside our door. I have noticed that this receptacle is rarely used by the general public or people passing by. The receptacle is currently emptied one day a week by a scheduled garbage truck. I assume the city pays the bill.



AN ORDINANCE UPDATING AND AMENDING
THE STATUTORY REFERENCES IN §§ 3.08, 3.081,
AND 3.082 OF THE CHIPPEWA FALLS MUNICIPAL CODE

THE COMMON COUNCIL OF THE CITY OF CHIPPEWA FALLS, WISCONSIN, DO ORDAIN AS FOLLOWS:

Several years ago Chapter 66 of the Wisconsin Statutes was renumbered. Certain statutory references in §§ 3.08, 3.081, and 3.082 of the Chippewa Falls Municipal Code relating to special assessments, need to be updated and amended to reflect that renumbering. The revisions are ordained as follows:

1. In § 3.08(1) “Ch. 66.62, Wis. Stats.” is revised to “Ch. 66.0701, Wis. Stats.”.
2. In § 3.08(7) “§ 66.60(12), Wis. Stats.” is revised to “66.0703(12), Wis. Stats.,” and “Section 66.62(2), Wis. Stats.,” is revised to “Section 66.0701(2), Wis. Stats.”.
3. In § 3.08(11) “§ 66.60(16), Wis. Stats.” is revised to “§ 66.0627, Wis. Stats.”.
4. In § 3.081(4) “§ 66.60(12), Wis. Stats.,” is revised to “§ 66.0703(12), Wis. Stats.,” and “§ 66.60(12)(f), Wis. Stats.” is revised to “§ 66.0703(12)(f), Wis. Stats.” and “§ 66.635, Wis. Stats.” is revised to “§ 66.0725, Wis. Stats.”.
5. In § 3.082 “§ 66.615(3)(f), Wis. Stats.,” is revised to “§ 66.0907(3)(f), Wis. Stats.,” and “§ 66.615, Wis. Stats.,” is revised to “§ 66.0907, Wis. Stats.”.

Dear Mr. CW King,

My name is Emily P. Sommerfeld, I live at 316 South Grove Street Chippewa Falls, Wisconsin. I am writing a letter of appreciation for putting a four-way stop at the intersection of Coleman street and Wheaton street, near the Chippewa Falls Senior High School. Here are my thoughts on why I think the city made the right decision when deciding to whether or not to put the four-way stop in.

As a teenage driver, driving is a scary thing. I drive everyday to school. My commute to school is about 10 minutes from my house to the high school. Before the four-way stop was put in, it would take me much more than 10 minutes. I would have to take a left turn to get to the parking lot. There have been times when I would have to sit at the intersection for minutes waiting for a safe time to complete my left turn. The intersection was a big nightmare after school, too. Again, I would sit at the intersection for minutes waiting for a safe time to cross. I would also like to acknowledge the fact that that you filled in the pot holes along Coleman street. I would have to drive along the median of the road, or sometimes on the left side to avoid them. I was worried about the alignment on my car and the negative effects it was having on my tires.

When I first heard about the four-way stop, I was a little nervous on how it was going to work with 1500 students coming to school and leaving the school at the same time. However, after a few days I was no longer nervous about it. The Coleman/Wheaton intersection is no longer a mad-house before and after school. It now takes me exactly 10 minutes to get to and from school, which is nice, especially when I'm running late. I am able to pull up to the intersection, wait for the three other cars to go, then it's my turn. It's almost brainless. I know that some people may be afraid of this relatively large change within the community. Other people may be concerned about the amount of money that two flashing stop signs costed. After further research, I found that one flashing stop sign costs about \$1,600.00 each. That means that two would cost \$3,200. I realize that \$3,200 is a lot of money, but that amount of money is keeping everyone safe. Thank you for showing your concern for our safety.

I appreciate your time and look forward to any comments you might have on this matter.
