ORDINANCE NO. 2013-

AN ORDINANCE AMENDING THE SPEED LIMITS  
CODE SECTION, § 7.02 (2)(c) OF THE CHIPPEWA FALLS  
MUNICIPAL CODE, TO CONFORM WITH PRESENT SIGNAGE  
AND TO CONFORM TO PRESENT STREET NAMING.

THE COMMON COUNCIL OF THE CITY OF CHIPPEWA FALLS, WISCONSIN,  
DO ORDAIN AS FOLLOWS:

1. That § 7.02 (2)(c) of the Chippewa Falls Municipal Code which presently provides as follows:

“7.02 SPEED LIMITS.

...

(2) SPEED LIMITS INCREASED. The speed limits are increased as hereinafter set forth upon the following streets between the limits designated:

...

(c) 30 mph.

Industrial Blvd. between Jeffers St. and Cashman Dr.

Jefferson Ave., north, on the lane leaving the City, from First Ave. to the City limits; and on the lane entering the City, from the City limits to First Ave.”

AN ORDINANCE AMENDING THE TRANSIT  
COMMITTEE CODE SECTION, §1.321(1)  
OF THE CHIPPEWA FALLS MUNICIPAL CODE  
REGARDING MEMBERSHIP THEREON

THE COMMON COUNCIL OF THE CITY OF CHIPPEWA FALLS, WISCONSIN,  
DO ORDAIN AS FOLLOWS:

1. That §1.321(1) of the Chippewa Falls Municipal Code, regarding membership thereon, which presently provides as follows:

**1.321 TRANSIT COMMITTEE.**

Effective July 1, 1977, and until further order of the Council, the Chippewa Falls Transit Committee is established upon the following terms and conditions:

- (1) **MEMBERSHIP.** The Transit Committee shall consist of 7 members appointed by the Mayor, subject to confirmation by the Council. The membership shall consist of 2 aldermen, 4 citizens of the City and 1 citizen from the Town of Hallie. At all times, there shall be 1 alderman from an even-numbered aldermanic district and 1 member from an odd-numbered aldermanic district. The initial appointment of members shall be as follows: 2 of the citizens appointed from the City shall be appointed for 2 years and 2 shall be appointed for a term of 1 year; the member from Hallie shall be appointed for 2 years and 1 alderman appointed for 2 years. Initially appointed aldermen may be from any ward. Thereafter, the term of office of all members shall be 2 years. All future appointments shall be effective May 1, and those members initially appointed for a 1-year term shall have their appointments expire on May 1, 1978, or when their successors are appointed and qualify.

**1.321 TRANSIT COMMITTEE.**

Until further order of the Council, the Chippewa Falls Transit Committee, established by Ordinance No. 1977-21, shall continue upon the following terms and conditions:

- (1) MEMBERSHIP. The Transit Committee shall consist of 7 members appointed by the Mayor, subject to confirmation by the Council. The membership shall consist of 2 alderpersons and 5 citizens from the City of Chippewa Falls. At all times, there shall be 1 alderperson from an even-numbered aldermanic district and 1 member from an odd-numbered aldermanic district. The term of office of all members shall be 2 years. All appointments shall be effective May 1.
